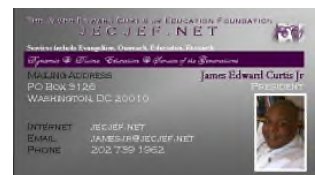

162 Thank you so much for your inquiry about membership in the Academy of Homiletics.

163

164 The membership guidelines for the academy read as follows: "Full membership may be offered by the Academy to any regular or  
165 adjunct faculty member in a graduate/professional school of theology who teaches preaching, and may continue for persons  
166 moving into other areas of ministry. Associate membership may be offered by the Academy to graduate students preparing to  
167 teach in the field of homiletics." The phrase "graduate students" has been understood to refer to people in PhD or ThD programs  
168 or post-doctoral fellowships.
